**New This Year - Rally & Trick Dog!**

**You can earn Trick Dog Titles at this event.**

**WHERE:** CALIFORNIA STATE UNIVERSITY EAST BAY - MUSIC-BUSINESS PERISTYLE LAWN, 25800 Carlos Bee Blvd, Hayward. From Hwy 880 in Hayward, take the Jackson Street exit eastbound. Turn right at first stop light onto Santa Clara which becomes Harder Rd. Follow to Cal State campus. Park in Lot K (Theatre) at the rear of the campus. No charge for parking at CSUEB on weekends. NO DRIVING ONTO THE GROUNDS ALLOWED AT ANY TIME. Be prepared to haul your equipment between the parking lot and the workshop site. Match will be held rain or shine. Shade is limited – please bring your own if possible.

**OBEDIENCE CLASSES:** BEGINNER NOVICE (1 ring), NOVICE (2 rings), OPEN (2 rings), UTILITY (2 rings), Rally (1 ring), Trick (1 ring).

**OBEDIENCE RULES:** Sanctioned "OC" Match.\* All breeds, mixed and rare breeds are welcome. Limited entries. No awards to be given, legs WILL NOT be earned towards obedience titles. Toys and food are permitted. Collars should comply with AKC regulations; no prong or electric collars allowed. Corrections limited to verbal corrections or gently guiding the dog. **PRE-ENTRY ONLY.**

**TRICK DOG:** All levels are offered. Novice, Intermediate, Advanced, and Performer. Please bring the forms for your level with you. Forms may be found on the AKC website: <http://www.akc.org/trick-Dog/trick-dog-applications/>. If you are going to perform tricks involving props please bring those as well. **PRE-ENTRY ONLY.**

**ENTRY FEES:** Fees for Obedience & Rally are \$18.00 for first entry and \$12.00 for additional entry for same dog. Limit of two obedience entries per dog. **Trick Dog Fees: \$12.00 per dog per level.** Trick Dogs limited to 25 dogs total for all levels. If dogs are entered at multiple levels each level counts as one towards the 25 dog limit.

**Entries must be received by Saturday, May 26, 2018.** NO REFUNDS after May 26. No day-of-match entries.

**JUDGING SCHEDULE:** Entries will be confirmed with an e-mail by Wednesday, May 30, 2018.

**JUDGING TIME:** Obedience and Rally rings begin at 8:30 AM. Trick Dog Testing will start at 9:00 a.m.
