Litter listing requirements:

Members may submit litter listings for their dogs or bitches. As stated in the GGLRC Breeders Code of Ethics, before a litter will be listed in Retriever Reflections, you must submit health clearance information for both the dog and the bitch: OFA or Wind-Morgan clearances and certification by a board-certified veterinary ophthalmologist that the dog has been examined and found free of hereditary eye disease within the last year. You must indicate whether or not the parents have met the Code of Ethics performance requirement (CD, one championship point, JAM, field title, WC, or GGLRC Retrieving Dog Elementary certificate).

We require a \$10 donation to Golden Gate Labrador Rescue for a litter listing. Each listing may appear twice. Please submit listings in writing to Editor, Melinda Grosch. Make checks payable to GGLRC and send to: Nancy Yamada, Treasurer, 42 Roosevelt Circle, Palo Alto, CA 94306

The litters or sires listed here belong to members in good standing of the Golden Gate Labrador Retriever Club, Inc. (GGLRC), but in no circumstances does GGLRC guarantee the services of said members.

IMPORTANT LEGISLATIVE NEWS

AB 1634 California Healthy Pets Act

AB 1634 "California Healthy Pets Act" has been made into a "two year" bill and will reappear in January 2008. PetPac and Concerned Dog Owners of California (CDOC) will be continuing to monitor Levine's amendments and changes to this bill. Levine was specifically directed to work with the various interest groups. At the AKC Legislative workshop held after the Senate hearing (which I attended) they said that they will attempt to contact and work with Levine as the first step. If the bill comes back with unacceptable and unworkable provisions as it has up to this point then the AKC, PetPac, and CDOC will spearhead opposition and possibly propose our own legislation. STAY TUNED!

Martha Shaw (VP) opening comments: Allen was unavailable to attend due to a change in his schedule. First and foremost AB1634 has been postponed. GGLRC participated in the campaign against 1634 and we plan on continuing a proactive approach to proposed legislation.

Secretary's Report

AB1634 (mandatory spay/neuter bill) was postponed to next year, but has not gone away. GGLRC took a proactive role by letter writing to the various politicians expressing our "NO on AB1634" position. We have been contacted by two

organizations, PetPac and CDOCA (Concerned Dog Owners of California – New) for contributions to support the efforts of these non profit groups. I recommend a significant donation, \$500 to each of these organizations that are actively pursuing legislative developments in the dog – pet – legislative world. Their contributions to the defeat of AB1634 were significant. Melinda suggested and board approved putting ads into the specialty catalog for both organizations. Martha will do this with some help from Melinda. The organization information will also be presented in the next newsletter and include envelopes to go directly to the organizations for individual contributions.

Since we are now out in the orchard, another tent

from the fairgrounds was proposed and approved. Along with the tents that come with the rings, we will have another tent (10×35) at a cost of approximately \$200.00. This will accommodate raffle and trophy's .

Need to hire the ring stewards. Also need raffle ticket sellers. Frank & Joyce Robbins volunteered for catalog sales.
