#### PRESIDENT'S MESSAGE

"I wish my dog could do that..." I hear this phrase uttered frequently when someone sees a dog sitting quietly in a public place awaiting the return of its owner/guardian. I might be reading too much into it, but it seems to imply there is a dog at home that isn't getting out as much as a well behaved canine might be. I know I am preaching to the choir here, as most all of you are very experienced trainers, so as you know, basic training is the gateway to all the other fun things we do with our dogs (field work, rally, tracking, "Splash Dogs", therapy, conformation, etc.)

You won't find me throwing stones about obedience though, as I fall off the training wagon frequently. This couldn't have been more evident to me than when I had the opportunity to steward the "Utility B" ring at an Obedience Trial recently. I marveled at the ability of the dogs and the patience of the handlers. Particularly fascinating to me was the scent discrimination exercise where the dog had to pick one item (out of nine) that was recently scented by the handler's touch. Not only did the dog have to do this once on leather item but yet again on a metal one. And that is just but one exercise in a routine that included off leash heeling, hand signal recognition, directed jumping, and directed retrieve. One woman who was competing in Utility has in excess of twenty UDX's!!

I feel lucky to have discovered my dog training club (www.SLDTC.org ) early on in my journey with dogs. A club environment for training usually offers a comfortable venue, regular classes with great instructors, and most importantly, a tremendous support group of committed enthusiasts.

My club, San Lorenzo DTC is a member club of the larger network "Associated Obedience Clubs of Northern California" (www.aocnc.org ) AOCNC serves as a clearing house for local obedience clubs facilitating inter-club communication and hosting a an inter-club competition each year. But most of all, go out and have some fun with your dog!!

#### Litter listing requirements:

Members may submit litter listings for their dogs or bitches. As stated in the GGLRC Breeders Code of Ethics, before a litter will be listed in Retriever Reflections, you must submit health clearance information for both the dog and the bitch: OFA or Wind-Morgan clearances and certification by a board-certified veterinary ophthalmologist that the dog has been examined and found free of hereditary eye disease within the last year. You must indicate whether or not the parents have met the Code of

Ethics performance requirement (CD, one championship point, JAM, field title, WC, or GGLRC Retrieving Dog Elementary certificate).

We require a \$10 donation to Golden Gate Labrador Rescue for a litter listing. Each listing may appear twice. Please submit listings in writing to Editor, Melinda Grosch. Make checks payable to GGLRC and send to:

#### FIELD TRAINING DAYS AND WORKING CERTIFICATE TEST

The Field training day on Saturday, September 26<sup>th</sup>. at Ornbaun Kennels in Suisun was HOT but we had relatively nice water for the dogs.

We have had some setbacks to the planned Working Certificate as Ornbaun's will be closing on October 17<sup>th</sup> in anticipation of duck season which opens on Sat., October 24<sup>th</sup>. Jones Lake is currently unavailable and no other suitable location has been discovered. At worst it will mean a delay until after duck season (probably until February).

### LEGISLATION - DOGS AND THEIR OWNERS WIN THE DAY (for now)

SB 250 died in the Assembly and it remains to be seen how it will be handled as a two year bill - stay tuned for January 2010.

Other bills that did not garner as much attention faired as follows:

Governor Schwarzenegger has taken action on numerous bills. So far today, October 12th, he has signed 89 bills and vetoed 94 bills.

VETOED ==> AB 241 by Assemblymember Pedro Nava (D-Santa Barbara) - Dogs and cats: breeding for sale.

To the Members of the California State Assembly:

I am returning Assembly Bill 241 without my signature. This measure would make it a crime for any person or entity to own or control more than 50 unsterilized adult dogs or cats for breeding or raising for sale as pets. I support measures designed to prevent animal cruelty and that punish persons engaged in the abuse of animals. However, this measure simply goes too far in an attempt to address the serious problem of puppy mills. An arbitrary cap on the number of animals any entity can possess throughout the state will not end unlawful, inhumane breeding practices. Instead this measure has the potential to criminalize the lawful activities of reputable breeders, pet stores, kennels, and charitable organizations engaged in raising service and assistance dogs. For these reasons, I am unable to sign this bill.

VETOED ==> AB 243 by Assemblymember Pedro Nava [D-Santa Barbara] - Animal abuse: penalties.

To the Members of the California State Assembly:

I am returning Assembly Bill 243 without my signature. This bill would require a judge to make an order prohibiting a person convicted of specified animal-related crimes from owning, possessing, or caring for any animals for a minimum period of time. This measure is unnecessary. Judges already have the

discretion to enter an order forbidding persons from caring for animals if it's warranted. Making this order mandatory could unjustly impact individuals who make a living working with or caring for animals. Consequently, I am unable to sign this bill.

VETOED ==> AB 1122 by Assemblymember Ted Lieu [D-Torrance] - Animal abuse: sale of live animals.

To the Members of the California State Assembly:

I am returning Assembly Bill 1122 without my signature. I am concerned with the scope and unintended consequences of this bill and that it does not assure the humane and ethical treatment and welfare of animals. This bill has unknown costs associated with the enforcement and implementation of prohibiting the sale of live animals in specified venues and could drive the selling of animals underground or to private sites. For this reason I am unable to sign this bill. Sincerely, Arnold Schwarzenegger

10/11/2009 FOR IMMEDIATE RELEASE Governor Schwarzenegger Signs Legislation Increasing Punishment for Dogfighting

Governor Schwarzenegger today announced that he has signed legislation increasing punishment for those found guilty of participating in and attending organized dog fights.

SB 318 by Senator Ron Calderon (D-Montebello) provides procedures for the forfeiting of property acquired through the crime of dogfighting and AB 242 by Assemblymember Pedro Nava (D-Santa Barbara) imposes stricter penalties on those found guilty of attending dog fights.

"Organized dogfighting is a horrible and inhumane crime that brings cruel violence to our neighborhoods," said Governor Schwarzenegger. "These bills will increase the punishment for spectators at dog fights and will allow our law enforcement officials to confiscate the profits of this illegal activity."

SB 318 provides mandatory forfeiture procedures of property and profits acquired by organizers and participants through organized dogfighting. The bill states that the prosecuting agency in any dogfighting crime must file a petition for forfeiture.

AB 242 increases the penalty for being or intending to be a spectator at a dog fight from a misdemeanor punishable by up to six months in a county jail to imprisonment in a county jail not to exceed one year, or by a fine not to exceed \$5,000, or by both.

In 2006, the Governor signed SB 1349 increasing the penalty for causing any animal to fight with another animal.
